This single application applies for all of the dates. You may apply for as many or few dates as you would like. All of our applicants will be evaluated by the FOTS Board of Directors.

PLEASE NOTE: Sales are only allowed during the listed market hours. Sales before 3pm are forbidden in the interest of fairness, and leaving the market before the stated end time will invalidate your participation in any future Farmers on the Square markets.

PLEASE NOTE: Due to increasing interest in participation in our Artisan Markets, vendors may be added to a waiting list for any market date if they cannot be guaranteed space immediately. Waitlisted vendors will not be invoiced for these dates initially, but may be contacted at any time (likely the week before a market) when space becomes available. Waitlisted vendors will be expected to respond within 24 hours in order to confirm their participation, otherwise the Market Manager will reach out to another vendor. Payment of \$44 for the day will be due by the start of the market for waitlisted vendors.

Do not send payment until your application is approved. Vendor fees due will be assessed according to the amounts listed above. **Full payment for ALL scheduled dates is required BEFORE making any sales;** therefore, you should pay **on or before the day of your first market** to ensure you are allowed to participate. You can pay at the market with cash or check made out to Farmers on the Square, or send your payment via mail to the PO Box below, AFTER confirmation of approval. **(DO NOT send mail to the church!)**
